

Rules and Regulations

The primary focus of this competition is to give all participants a pleasant learning experience.

*Rules and Regulations (Please read carefully before completing application).

- (A) Age Requirement: All applicants must be not less than 13 years of age nor more than 18 years of age as of the audition date.
- (B) Audition Procedure:
- * (1) Each dancer shall be required, either in the application or by letter received prior to the actual audition, to advise the Foundation as to the names of the variations being performed, the composer and choreographer.
 - * (2) Class in presence of Judges.
 - * (3) Technical solo (en pointe if female) in practice clothes or costume; either original or from standard repertoire.
 - * (4) Dramatic or narrative dance choreographed in any idiom except tap (simple costume suggestion may be used if desired along with only necessary and minimal props); the dramatic or narrative dance shall **NOT** be en pointe.
 - * (5) Each dance solo may not exceed three (3) minutes.
 - * (6) Candidate to provide own CD for accompaniment. Each variation is to be on a separate CD.
 - (7) Judging Panel to consist of between 3-5 individuals to include known dance critics, dance educators and dance professionals.
- (C) Scholarships totalling not less than \$1500.00 shall be awarded with distribution of the scholarships among contestants to be as determined by the Foundation.
- (D) Scholarship monies will be issued to further the dance education of the winner and will be paid directly to the teacher and/or institution selected by the winner, subject to the approval of such teacher or institution by the Foundation. All scholarship money is to be expended by the recipient within one (1) year from the time it is awarded.
- * (E) All applications must be received by the Foundation at least thirty (30) days before the scheduled audition date and applications are to be mailed to:
